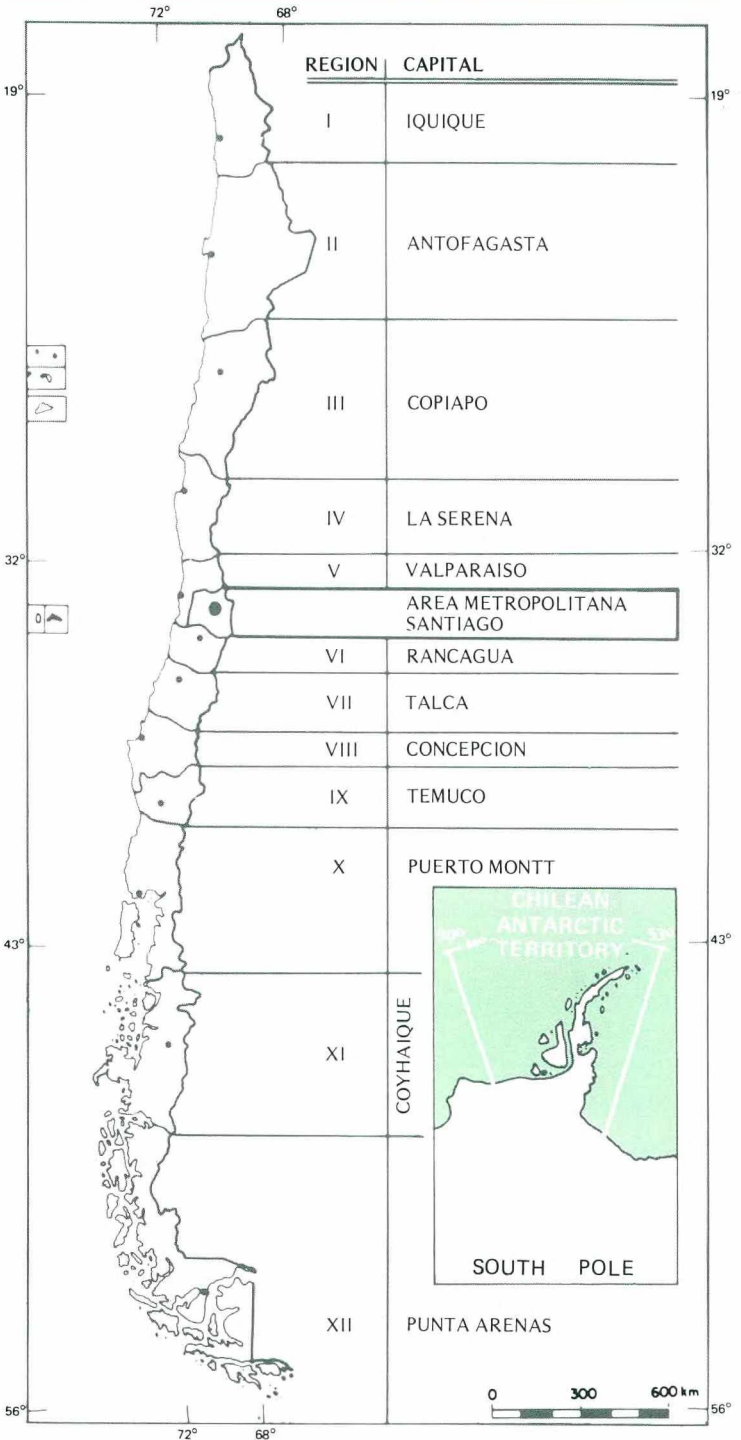

GENERAL BACKGROUND (A)

LOCATION AND EXTENSION:

Chile is located in the southwestern part of South America stretching as far south in Antarctica as to the South Pole and with its western most province of Easter Island, in the South Pacific, Oceania.

On the American continent, Chile stretches from parallel 17°30' of south latitude in the northern boundary to parallel 56°32' of south latitude in the southern most tip of South America.

The Chilean Antarctic Territory comprises the whole of the area located between meridians 53° and 90° of west longitude as far as the South Pole at 90° of south latitude.

The national territory comprises several islands in the Pacific Ocean, which add to the country's territorial sea. The nearest to the continent are the islands that form the Juan Fernández archipelago, San Félix and San Ambrosio. The most distant from the mainland are Sala y Gómez and Easter Island, also known as Rapa Nui.

The latter is located at 27° of latitude south and 109°30' of longitude west, opposite the port of Caldera and 3,760 kilometers away from mainland.

From the Concordia Line to the South Pole, the country is over 8,000 kilometers long. The area of Continental, Antarctic and Oceanic Chile is 2,006,626 square kilometers, with 756,626 sq. km. corresponding to South American Chile and 1,250,000 sq. km. to the Chilean Antarctic Territory.

BOUNDARIES:

Chile is bounded on the north by Perú, by a border line known as "Línea de la Concordia"; on the east by Bolivia and Argentina, mainly by a line that runs through the highest summits of the Andes; on the south by the South Pole, and on the west by the Pacific Ocean, including 200 nautical miles of territorial waters.

CLIMATE AND NATURAL RESOURCES:

The North:

Climate: Desert.

Natural resources: Nitrate, copper, iron, lithium and other minerals, valleys suited for agriculture, sea foods.

The Center:

Climate: Mild and temperate, with rains in winter.

Natural resources: Agricultural and grazing lands, forests, hydroelectric power (rivers), copper, coal, sea foods.

The South:

Climate: Temperate and rainy.

Natural resources: Agricultural and grazing lands, forests, hydroelectric power (rivers), copper, coal, sea foods.

The Austral Region:

Climate: Cold steppe.

Natural resources: Forests, petroleum, natural gas, coal, limestone, sheep, sea foods.

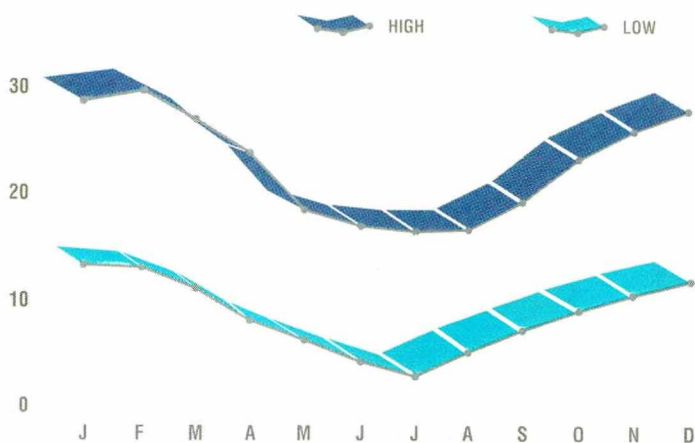

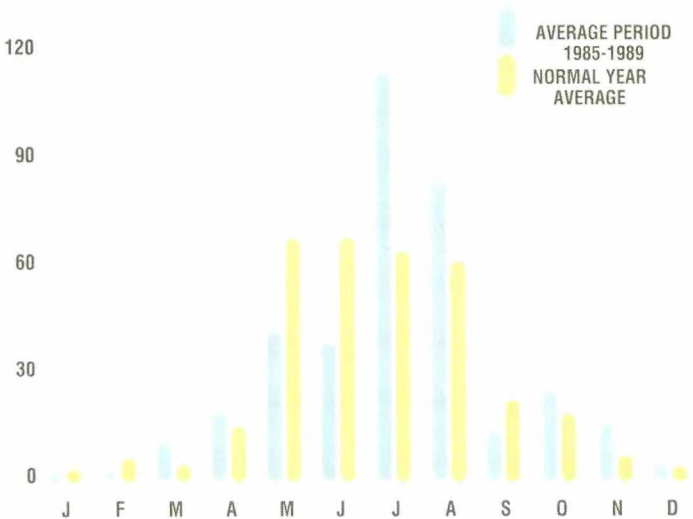
AVERAGE TEMPERATURES IN SANTIAGO

GENERAL BACKGROUND:

According to different censuses, Chile had 1,103,036 inhabitants in 1835 and 2,695,625 inhabitants in 1895. In 1907, there were 3,231,022 inhabitants, amount that rose to 5,023,539 in 1940 and to 7,663,171 in 1960.

The census carried out in 1970, showed a figure of 9,339,665 inhabitants and the latest census, of April 1982, registered a country's population of 11,329,736 people.

At present, according with projections made by the National Bureau of Statistics, the population in 1989 is of 12,961,032 persons.

This sustained growth can be mainly attributed to the persistence, until 1962 of moderately high birth rates (37.5‰ as an average) and to the decline of the mortality rate, which resulted in an increase of the average Chilean life expectancy from a level of 67.2 years in 1975 to 70.2 years in 1979 and 71.9 years in 1989.

In recent years, the Chilean population has been undergoing a slow process of aging due to a rapid drop in fertility rate. At present, the birth rate fluctuates at about 2.2% per year and the general mortality rate at 0.6%, with a vegetative growth of 1.7% per year.

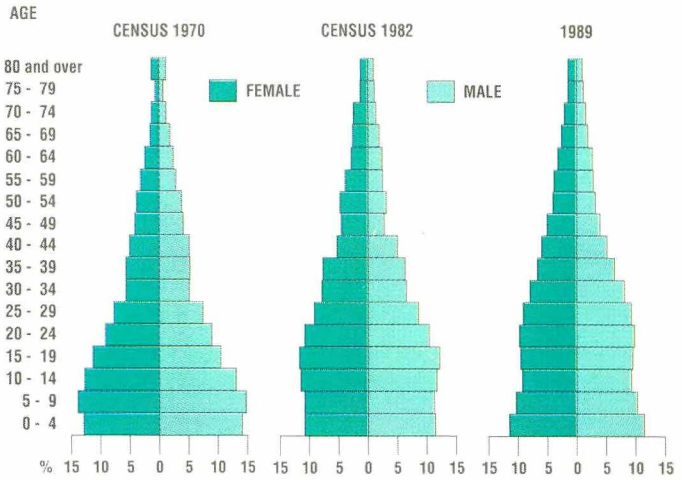
Rural population prevailed up to 1940. In 1875, it represented the 73% and in 1920 the 54%. Since the 1952 census, this situation was reversed; the 1982 census showed that the rural population accounted for 17.8% of the total population. Estimated figures for 1989 point out that the rural population is only a 15.7% of the total.

At present, Chile has a population density of 16 inhabitants per square kilometer, which is one of the lowest figures in Latin America. This is due to the fact that over 70% of the continental surface is desert, mountainous or has some other type of severe constrain for human settlement.

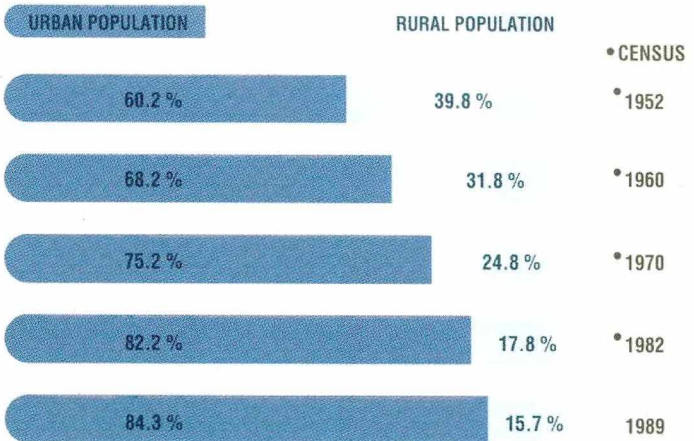

GOVERNMENT SYSTEM: POLITICAL AND ADMINISTRATIVE ORGANIZATION

According to the 1980's Political Constitution, Chile is a unitarian state. For administrative and interior government purposes, the country is organized in regions, and these, are divided into provinces. For the purpose of local administration, the provinces are subdivided into communes.

The regional, provincial and communal government systems are hierarchically structured. At the head of each region's administration is the Intendant, who is in charge of directing and administrating the region, and is advised by a Regional Council of Development and a Regional Secretariat of Coordination and Planning.

The Governor, subordinated to the Regional Intendant and as his representative is in charge of the government and administration of each province. He is assisted by an Advisory Technical Committee and by a Provincial Council.

In charge of the communal management is the Mayor, assisted by a Communal Council of Development and by a Communal Secretariat of Coordination and Planning.

The base of the system is the commune, since it is there that the organized participation of the community takes place. Within the system, the Ministries act in a decentralized way through the Regional Ministerial Secretariats.

THE REGIONS AND THEIR CAPITALS

Decree Laws 575 (July 10, 1974), 1,250 (Oct. 27, 1975) and 1,317 (Dic. 31, 1975), divided the Chilean territory in thirteen regions:

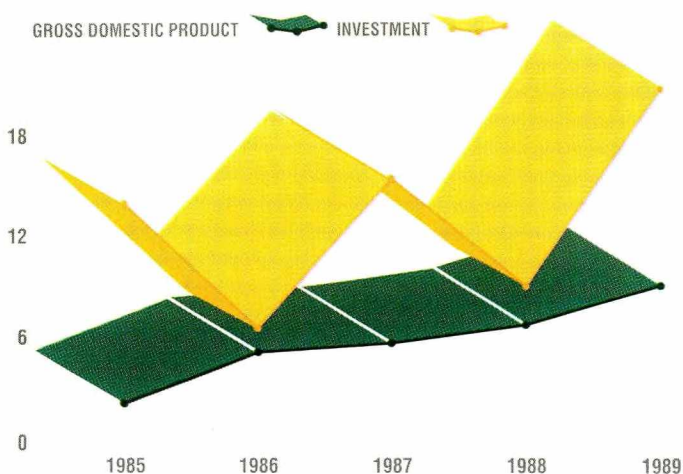

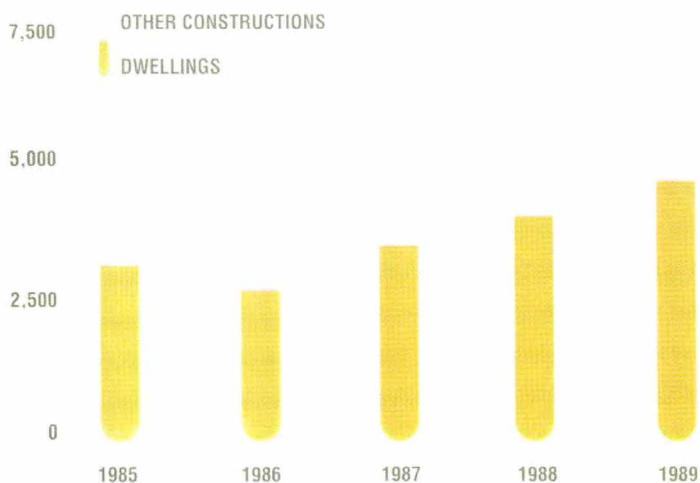

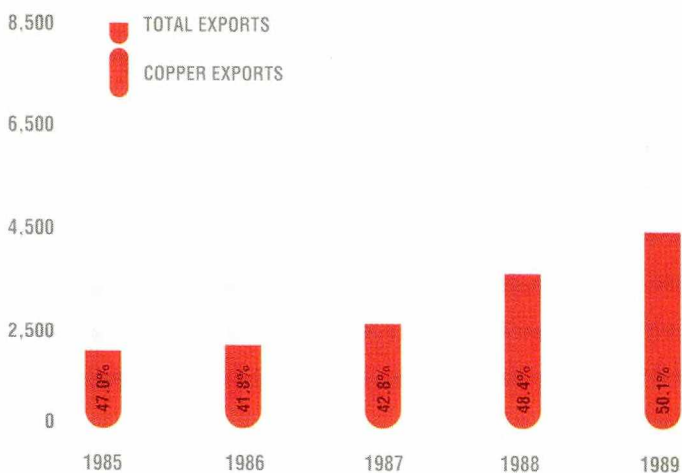

INCIDENCE OF COPPER IN TOTAL EXPORTS

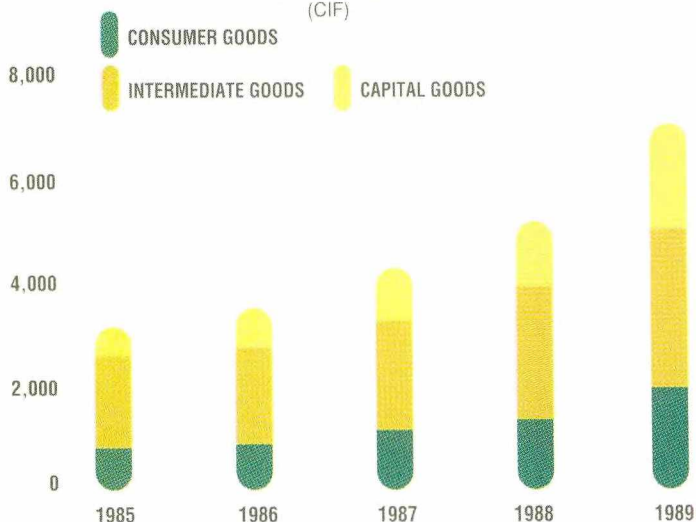

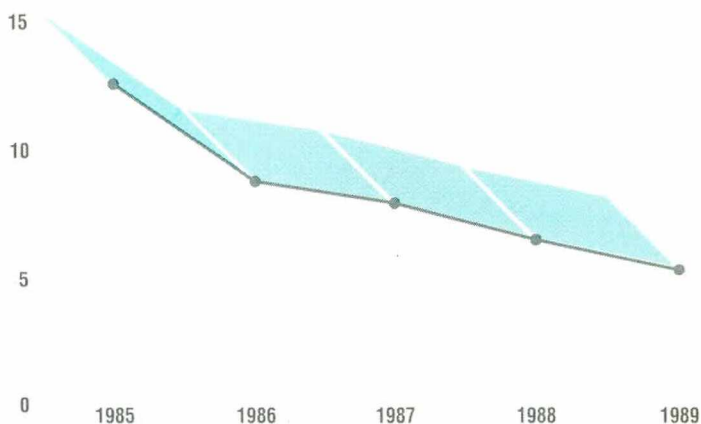

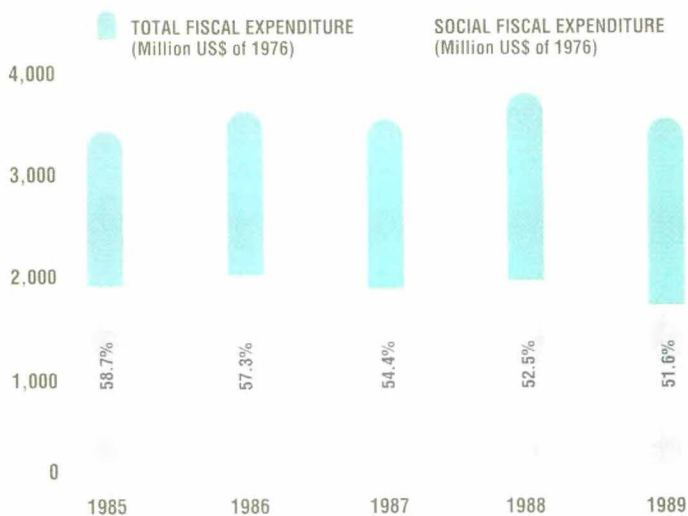
UNEMPLOYMENT RATE (AT NATIONAL LEVEL)
